



MOBILE PHONES and SMART DEVICES

STUDENT USE

PURPOSE

To explain to our school community the Department's and Clifton Springs Primary School's policy requirements and expectations relating to students using mobile phones, and other personal mobile devices, during school hours.

SCOPE

This policy applies to:

1. All students at Clifton Springs Primary School and,
2. Students' personal mobile phones, and other personal mobile devices, brought onto school premises during school hours, including recess and lunchtime.

DEFINITIONS

A mobile phone is a telephone with access to a cellular (telecommunication) system, with or without a physical connection to a network.

For the purpose of this policy, "mobile phone" refers to mobile phones and "smart devices" refers to any device that may connect to or have a similar functionality to a mobile phone, such as smart watches.

POLICY

Clifton Spring Primary School understands that students may bring a personal mobile phone or smart device to school, particularly if they are travelling independently to and from school.

At Clifton Springs Primary School:

- Students who choose to bring mobile phones to school must have them switched off and securely stored during school hours
- Students who choose to wear smart devices must have the internet connectivity function turned off. This includes sending and receiving messages
- Exceptions to this policy may be applied if certain conditions are met (see below for further information)
- When emergencies occur, parents or carers should reach their child by calling the school's office.
- Students need to speak to their teachers if they need to contact their parents.



Personal mobile phone use

In accordance with the Department's [Mobile Phones — Student Use Policy](#) issued by the Minister for Education, personal mobile phones or smart devices must not be used at Clifton Springs Primary School during school hours, including lunchtime and recess, unless an exception has been granted.

Where a student has been granted an exception, the student must use their mobile phone for the purpose for which the exception was granted, and in a safe, ethical and responsible manner.

Secure storage

Mobile phones owned by students at Clifton Springs Primary School are considered valuable items and are brought to school at the owner's (student's or parent/carer's) risk. Students are encouraged not to bring a mobile phone to school unless there is a compelling reason to do so. Please note that Clifton Springs Primary School does not have accident insurance for accidental property damage or theft. Students and their parents/carers are encouraged to obtain appropriate insurance for valuable items. Refer to Clifton Springs Primary School's Personal Property Policy AND/OR the Department's [Claims for Property Damage and Medical Expenses policy.](#)

Where students bring a mobile phone to school, Clifton Springs Primary School will provide secure storage. Secure storage is storage that cannot be readily accessed by those without permission to do so. At Clifton Springs Primary School, students are required to store their phones:

- Switched off: and
- Kept in the student's bag or signed in and given to the school administration office to be placed in a lockable cupboard.

Enforcement

Students who use their personal mobile phones or smart devices inappropriately at Clifton Springs Primary School, may be issued with consequences consistent with our school's existing student engagement policies (School ICT agreement, Student Wellbeing and Engagement Policy, Code of Conduct and Bullying Policy)

At Clifton Springs Primary School inappropriate use of mobile phones is **any use during school hours**, unless an exception has been granted, and particularly use of a mobile phone:

- in any way that disrupts the learning of others
- to send inappropriate, harassing or threatening messages or phone calls
- to engage in inappropriate social media use including cyber bullying
- to capture video or images of people, including students, teachers and members of the school community without their permission
- to capture video or images in the school toilets, changing rooms, swimming pools and gyms
- during exams and assessments

At Clifton Springs Primary School inappropriate use of smart devices is anything other than the original intended use of the device, **i.e., using a watch to tell the time**, unless an exception has been granted, and particularly:

- in any way that disrupts the learning of others
- to send inappropriate, harassing or threatening messages or phone calls
- to engage in inappropriate social media use including cyber bullying



- to capture video or images of people, including students, teachers and members of the school community without their permission
- to capture video or images in the school toilets, changing rooms, swimming pools and gyms
- during exams and assessments

Exceptions

Exceptions to the policy:

- may be applied during school hours if certain conditions are met, specifically,
 - Health and wellbeing-related exceptions; and
 - Exceptions related to managing risk when students are offsite.
- can be granted by the Principal, or by the teacher for that class, in accordance with the Department's [Mobile Phones — Student Use Policy](#).

The three categories of exceptions allowed under the Department's [Mobile Phones — Student Use Policy](#) are:

1. Learning-related exceptions

Specific exception	Documentation
For specific learning activities (class-based exception)	Unit of work, learning sequence
For students for whom a reasonable adjustment to a learning program is needed because of a disability or learning difficulty	Individual Learning Plan, Individual Education Plan

2. Health and wellbeing-related exceptions

Specific exception	Documentation
Students with a health condition	Student Health Support Plan

3. Exceptions related to managing risk when students are offsite

Specific exception	Documentation
Travelling to and from excursions	Risk assessment planning documentation
Students on excursions and camps	Risk assessment planning documentation
When students are offsite (not on school grounds) and unsupervised with parental permission	Risk assessment planning documentation
Students with a dual enrolment or who need to undertake intercampus travel	Risk assessment planning documentation



Where an exception is granted, the student can only use the mobile phone or smart device for the purpose for which it was granted.

Camps, excursions and extracurricular activities

Clifton Springs Primary School will provide students and their parents and carers with information about items that can or cannot be brought to camps, excursions, special activities and events, including personal mobile phones.

Exclusions

This policy does not apply to

- Out-of-School-Hours Care (OSHC)
- Out-of-school-hours events
- Travelling to and from school
- Wearable devices
- iPads and all other personal devices

COMMUNICATION

This policy will be communicated to our school community in the following ways:

- Available publicly on our school's website
- Conveyed through Compass
- Included in staff induction processes and staff training
- Included in school newsletter
- Included in staff handbook/manual
- Discussed at annual staff briefings/meetings
- Included in transition and enrolment packs
- Discussed at parent information nights/sessions
- Hard copy available from school administration upon request
